A Petition Asking for International Social Security Agreements

Japan Foreign Council, Inc., jointly with Keidanren and Japan Overseas Enterprises Association, addressed a petition to the government and political parties asking for further promotion of international social security agreements.

Most of advanced countries in the world have their own public social security schemes in which all residents, including foreigners, are required to participate. However, foreigners who eventually go back home after certain period of business assignment in overseas country need to keep paying social security premiums in home country during their absence, otherwise they may lose the right to receive their pension after retirement.

In most cases, international enterprises bear such additional costs, since quite often paid-up premiums may be eventually wasted because of shortage in minimum period required for maturity refund. Foreign companies in Japan have also similar problems.

But, such burden will be eliminated if two countries conclude a bilateral agreement to avoid double payments. Japan, so far, concluded such agreements with 7 countries, i.e., Germany, U.K., South Korea, U.S., France, Belgium and Canda, but far behind from other countries such as U.S., France and Canada in terms of number of agreements.

JFTC, Keidanren and Japan Overseas Enterprises Association conducted a survey on various other countries to investigate magnitude of double payments and suggested a priority of countries Japan should start negotiations for such international agreements. Based on such investigation, the following petition was submitted.

"Promoting the Conclusion of More International Social Security Agreements"

The globalization of economy is making corporate activities increasingly borderless. The freer and more flexible business environments are inevitable for Japanese companies to compete with overseas rivals.

As such, we came up with requests on September 17, 2002 titled "Requesting the Early Conclusion of Social Security Agreements", in which we pointed out that the duplicate payments of public social insurance premiums for oversea representatives impose heavy burdens on enterprises and thus requested Government of Japan promote agreements on social security with advanced countries as soon as possible to eliminate such problems.

Since then, Japan has concluded such agreements with the U.S. and four other countries, increasing to 7 countries it has signed to date. It is expected, as a result, that mutual economic exchanges with these countries will be deepened further in the future.

On the other hand, however, the U.S. has already concluded similar agreements with more than 20 countries, and France and Canada, even more than with 40 countries. Taking such fact into consideration, it is strongly desired that Japan, living via trading and investment, promote the conclusion of such agreements with more countries, with the following points in mind.

1) Further Promotion of Social Security Agreements

We recently conducted joint investigations on social insurance scheme in total 24 countries in ASEAN, EU and Latin America supported by local Japanese chambers of commerce. As a result, it revealed that duplication in payments exists in 13 countries and that burdens are heavy, particularly in Italy (total amount: ¥4.5 billion a year for Italy), the Czech Republic (¥2.9 billion), Brazil (¥2.14 billion), Spain (¥1.29 billion) and Hungary (¥300 million). The Japanese chamber of commerce in the Czech Republic submitted a petition desperately asking for the conclusion of such agreement to solve such problems.

We understand that Government of Japan is devoting itself to promote preliminary discussions or negotiations with various countries. We hope that Government of Japan will take the results of our investigations into consideration and make efforts to realize such agreements as soon as possible with more countries.

2) Implementation of a Comprehensive Exemption Law in Japan

After starting negotiation with counterpart country, it

takes substantial time until the social security agreement legally comes into effective. Even after signing agreement, the Diet bill for approval of such agreement and another Diet bill for approval of special exemption laws to harmonize with existing domestic laws have to go through examination separately and simultaneously.

However, according to our observation on the Diet process in the past, very tight schedule for discussions on many bills in the Diet session quite often forced those bills nearly to be left behind, though those bills were approved unanimously in the end.

Delays in approval process in the Diet would delay the implementation of agreements, which would force enterprises to keep shouldering additional costs that they do not have to in principle and cause huge losses.

Given the fact that such bills have all been approved unanimously in the Diet in the past, we request that the individual exemption laws so far being tailored to specific social security agreement on a country-by-country basis be combined into a single comprehensive exemption law to cover future social security agreements to come, so that necessary Diet approval can be focused only for social security agreement in the future.

Contributing to Society with Human Resources ----- Action for a Better International Community (ABIC) -----

More than six years have passed since Action for a Better International Community (ABIC), a private non profit organization, was established in April 2000 by the Japan Foreign Trade Council, Inc. (JFTC). ABIC has already solidified its foundation as an NPO and is now working to ensure further development toward the future.

Currently with about 1,600 registered members, who are mostly trading-firm retirees, ABIC makes it its mission to contribute to society domestically and internationally, in principle, by utilizing human resources with linguistic skills and global business experience. At the request of a company or organization, whether it is at home or abroad, ABIC can introduce them to an expert best suited to their specific needs for foreign language ability, functional skills, merchandise knowledge and other fields. Such experts provide the client with professional services at very reasonable prices.

Regarding activities related to foreign corporations, ABIC is helping them succeed in doing business with Japanese companies. For example, ABIC makes arrangements for interpreters for overseas exhibitors participating in trade shows held in Japan. Chosen from those with professional knowledge about each client's products and industry, the interpreters can serve concurrently as a business adviser. They are called, therefore, "bilingual business adviser" rather than mere "interpreter". During the "Health Ingredients Japan 2006" trade show held at Tokyo Big Sight on October 4-

6, 2006, as many as 12 bilingual business advisers were employed by foreign firms, setting a new record in the number of advisers per trade show.

Bilingual business advisers are also utilized by foreign enterprises when they visit Japanese corporations on business. By the same token, ABIC bilingual professionals are useful for such services as market research on a specific Japanese product or industry, lectures on the Japanese market for a particular kind of merchandise and comprehensive support to start up a business in Japan.

Last year, an ABIC member was appointed as an investment evaluator by a UN agency for drawing up an assessment report on the outcome of an aid project implemented in an African country. After visiting the project site for investigations and interviews, he completed it satisfactory based on the knowledge acquired during his tenure with a Sogo Shosha, a general trading company.

On a long-term contract basis, several members are employed by foreign manufacturers as representatives stationed in Japan, while others are working for the Tokyo office of foreign-affiliated corporations as an English-speaking accountant and for a factory in a Southeast Asian country as a superintendent. Now, ABIC hopes that more members will be employed by foreign embassies in Japan and government agencies both in Japan and abroad.

Besides the above, ABIC members are engaged in various activities internationally and domestically. With regard to those of outside Japan, many ABIC members have been dispatched to developing countries as business advisers in connection with the programs of the Japan International Cooperation Agency (JICA), the Japan External Trade Organization (JETRO) or the like. Also, in response to requests from Japanese NGOs operating in developing countries, ABIC has been providing them with personnel who can support their social contribution efforts there as a local manager or representative. Further, with the "TSUNAMI" disaster due to the massive tidal wave along the Indian Ocean, three ABIC members well versed in the Indonesian language were sent to Sumatra last year as interpreters to help the medical activities of the Japan Self-Defense Forces.

When it comes to activities at home, ABIC has been introducing many personnel to small and medium-sized enterprises who intend to expand their business with foreign companies or plan to branch out into overseas markets. The SMEs' lack of their own such staff for international businesses is compensated by the ABIC experts with linguistic ability and global business experience.

On a long-term contract basis, ABIC professionals are engaged in such activities as market development for SMEs' products as business facilitators, or management and operation of SMEs as business advisers. While, on short-time basis, they deliver lectures about a foreign country's situation to company employees who are about to be assigned to the country, give lessons on foreign trade practices to SMEs' employees at seminar held by an industry group, translate pamphlets and the like from

Japanese into a foreign language and vice versa, serve as an interpreter when an SME has visitors from abroad, and so on. Such professionals are often introduced to SMEs through municipal governments in Japan, since most of the governments have a public support system for the local SMEs to promote their business with foreign countries.

Meanwhile, ABIC sends many lecturers to various courses offered by universities, open colleges and other organizations. Included in the subjects for the lectures are foreign trade practices, international business and the global situation, corporate strategy for advancing into overseas markets, and much more. Also, to support educational programs for international understanding, ABIC members give class lectures at elementary schools as well as at junior and senior high schools. Each lecturer talks about a topic of a foreign country where they have resided. Further, ABIC offers charge-free Japanese language and Japanese culture classes to foreign

students and their families.

Of course, ABIC members work as volunteers. It is remembered that on the occasion of 2002 FIFA World Cup Soccer, many ABIC members worked behind the scenes without charge, making the most of the Spanish, French and other languages which they had mastered during their stay in the respective countries on business.

Although its activity to introduce capable human resources is appreciated by society, ABIC is not necessarily satisfied with the present situation. In the course of expanding its activities in the future, it wishes to add new functions in addition to introducing human resources, so that it can further strengthen both the quality and quantity of its contribution to society.
