# Bilingual "Japan's Foreign Trade 2007" published on March 22.

Japan Foreign Trade Council, Inc. published "Foreign Trade 2007" (Nihon Boeki no Genjo) on 22nd of March this year. A series of this handy booklet, a kind of the latest "Mini-White Paper on Trade" has been widely used among those interested in Japanese economy and trade since the first edition in 1976.

## — Introduction —

In 2006, Japan's trade was favorable in both exports and imports. The total value of exports reached some ¥7.5 billion due mainly to growth in volume, establishing an all-time high for the fifth consecutive year. That of imports totaled ¥6.7 billion, hitting a new record for the fourth consecutive year, against the background of rising prices. Consequently, the combined value of exports and imports broke the ¥140-trillion line to reach ¥142 trillion, a record high for the fifth consecutive year. Since imports increased greater than exports as seen in 2005, Japan's trade surplus (on a Customs-cleared basis) fell to ¥8.1 trillion.


Japan's 2006 trade was characterized by the following:

 As observed the previous year, Japan's trade with each BRIC (Brazil, Russia, India, and China) nation grew around 20 percent against the background of an expanding world economy, with prices of crude oil Japan Foreign Trade Council, Inc.

and natural resources hovering at high levels. Furthermore, trade was robust with the new economies of VISTA (Vietnam, Indonesia, South Africa, Turkey and Argentina) and Mexico, with which Japan had concluded an economic partnership agreement (EPA). Due to sharp increases in prices of import crude oil until the beginning of fall, trade with the Middle East maintained double-digit growth.

- 2) Trade with other countries and regions of Asia, approximately ¥65 trillion in value, accounted for nearly half of Japan's total external trade, according to the growth in horizontal trade. Among others, China (including Hong Kong) enhanced its presence as Japan's leading trade partner, taking a 20-percent share of Japan's total external trade.
- 3) By commodity, Motor Vehicles contributed significantly to total growth in exports as one of Japan's major export items. Notable increases in exports were also reported for machinery for capital investment and resource development (e.g., Metalworking Machinery and Construction Machines), Electrical Machinery (including Semiconductor etc), and raw materials (e.g., Iron & Steel products and Chemicals). Growth in imports was registered for Machinery & Equipment in general and high growth was observed, particularly in import of natural resources such as Petroleum, Iron Ore & Concentrates, and Ore of Nonferrous, as their prices remained high during 2006.
